Departments, Research Organizations (R&D Institutions), Medical Organizations, Universities, Schools, Colleges etc. We are extremely proud to the Government of India on their part has always given due recognitions and considerations to our representations.

Sir, this representation may be considered as a collective representation from all the Librarians in Justifying their positions as another segment of academic professionals who play equally a very important role in supporting, teaching and guiding.

It is universally accepted facts that Librarians provide academic services and supports to researchers, scientists, professors, teachers and students so that they may freely teach & guide to the students and the students may freely learn and the research libraries are to be scientifically organized and managed by professionally qualified library professionals to derive the real benefits of the quality research in India.

As a responsible professional body, the Indian Library Association (ILA) has been proactively involving/intervening through representations, discussions and other modes, with the Ministry of Science & Technology (MST), Govt. of India, BRIC-DBT for betterment of Librarians, Knowledge Managers, Library and Information Science Professionals (LIS) and libraries in the BRIC-DBT Research Institutions.

Here, we are submitting our point wise suggestions for your kind perusal and considerations for your newly constituted BRIC-DBT (https://bric.nic.in) a New Initiatives of MST, Govt of India.

- 1) Rename the name of "Library" to "Knowledge Resource Centre (KRC)" for all the DBT Institution, which has been already done in the CSIR (Ministry of Science & Technology), DRDO, IICA BARC etc.
- 2) Extend a new designation of "Scientist (KRC)" to Librarians (From Level 10 and above) in the all DBT Institutions under BRIC-DBT.
- 3) Promotion criteria to LIS professionals (Librarians) in the BRIC-DBT Institutions should be equated at par with the "Scientist/Professor" i.e. FCS Promotion to the Library Professionals under DBT-BRIC (as being followed in CSIR, DRDO, BARC etc.).
- 4) The entry level of the "Academic Librarians", (Level 10 and above) under DBT-BRIC Institutions should be at par with the "Scientist/Professor".
- Nomenclature of the Librarians & Staffing Patterns should be Uniform for all the DBT-BRIC Institutions.
- 6) Vacant Positions under Libraries/Knowledge Resource Centres should be filled at the earliest, wherever there is Incharge for Library in the BRIC-DBT Institutions.
- 7) BRIC-DBT should open a Department of Knowledge Resource Centre (Library) in those DBT Institution, who do not have the Library Department and fill with the LIS Professionals positions.

We earnestly believe that the honorable sir, could kindly resolve the above issues and kindly consider our above suggestions for creating productive professionals in the Library and Information Science domain in the BRIC-DBT, Govt. of India.

Further, we request you to kindly consider our proposal and given favorable recommendations to rectify the existing anomalies of the library professionals working in the BRIC-DBT Institutions in the country.

We look forward to your favorable consideration of these proposals and remain committed to supporting the advancement of knowledge and science in our country.
