This is to bring to your kind notice, the irregularities in the Advt. No. 1/RC(NT)/2023 for the post of Assistant Librarian as advertised on the website <https://www.jnu.ac.in/sites/default/files/career/AdvertisementNo-01-RC-NT-2023.pdf>

We wish to bring the following facts for your kind consideration:

1. The position of the Librarian falls under the academic cadre (Academic Non- Vacation) placed in the 'Academic Pay Level – 10'. which is regulated through "UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018' as per the relevant provisions there is no age bar for appointment of TEACHERS AND OTHER ACADEMIC STAFF'. Further, very recently, on the above subject matter, the University Grants Commission, vide its Public Notice no. F.No-3-1/2022 (JCRC), dated 15th November 2022, (copy attached as Ann-I) again clarified and re-iterated that the position of Assistant Librarians, etc. shall be regulated by the provisions contained in the UGC Regulation, 2018.


2. The upper age Limit shown in the advertisement is 40 years which is not in consonance with the above said notification.
